1 WE PROTECT YOUR MONEY **- Your Club. Your Money. Your Right to Transparency**

- Transfer Fee to be **FIXED** at **SGD 3,000**
- **NO INCREASE** in Subscription Fees
- **NO INCREASE** in Minimum Spending Levy (MSL) Current MSL to be reviewed
- **Independent External Audit** of **SGD 16.7 million**, with full disclosure to members. Completion of all outstanding Transformation Projects
- **Independent External Audit** of **Ayer Rajah Ground investment**, with full disclosure to members
- Ayer Rajah Grounds to be **managed in-house** by SRC Management and Staff
- All revenue and profits from Ayer Rajah Grounds to be **credited directly to SRC Account. NO managing agents, NO external vendors**

2 SPORTS & SOCIAL SECTIONS **- We Bring Back What Was Taken**

- **Review and Reinstate abolished sports sections.** Participate in NSAs in accordance with our Constitution
- **Empower and grant** Section Convenors and Subcommittees **full and unfettered autonomy** to run their sections. **NO dictatorship or interference** by the GCB Chair or President
- **Empower and grant** Section Convenors and Subcommittees **full autonomy to raise, manage, and utilise their own funds** through club facilities. **NO dictatorship or interference or financial control** by the GCB Chair or President

- **Launch structured in-house sports academies** across all disciplines through **SRC Junior Memberships**, led by **Section Convenors** and Subcommittees. **No Use of SRC facility by External Academies or Vendors**
- **Priority access** to fields, pickleball courts, tennis courts, and all facilities for SRC Section Members. **No rentals to external parties** that displace the use of the facilities for members
- Review and **reduce sports facility booking charges and guest fees**
- Reinstate the **Women's Wing**
- Restore **KTV and the Reading Room**
- Bring back **Monthly Social Club Nights**
- Reinstate **Jackpot operations** (subject to licence approval)

3 REAL VALUE. REAL COMMUNITY **- SRC must belong to all generations**

- Review and adjust **Food & Beverage pricing and portions** to ensure real value for members
- **NO cover charge for guests** on live band night. Continue **the 5 Live Band nights**
- Introduce **more family-focused events and programmes** to engage young families and millennials
- Conduct **Town Hall Meetings every six months**. Open dialogue, open books, **no silence, no secrecy**

4 CONSTITUTIONAL REFORMS VIA EOGM **- WE FIX THE SYSTEM**

- **Propose mandatory physical AND electronic voting**. Every member has a voice
- Propose EOGM requisition threshold at **100 members** — empowering the membership
- **Propose Leadership term limits** for President, Vice-President, GCB and Finance:
 - **Maximum of two terms**
 - **Mandatory step-down**
 - **No rotation or return to the Management Committee for the next two terms**
- **Review and Propose constitutional amendments** to limit and balance the powers of the Management Committee
