SRC SPORTS ACADEMY open tender notice outlines a public invitation for sports vendors to bid on a contract. Singapore Recreation Club (SRC) aims to foster competition, transparency, and potentially lower costs by allowing any qualified sports academy to participate.

Following are the open tender write-up details for sports academies' scope, requirements, evaluation criteria, and submission instructions.

- **PURPOSE:**

Singapore Recreation Club invite vendors of various sports namely, Basketball, Baseball, Netball, Pickleball, Rugby, Soccer, Softball, Tennis and any other sports discipline you would propose to be the club's collaborative partner; to set up academies under SRC branding.

- **SCOPE:**

The appointed Sports academies will carry the brand name of SRC Academies and provide specialized training to develop and hone sports skills, and to instil a broader range of sports development to nurture natural sporting talent.

- a. **SKILL DEVELOPMENT:**

- a. Academies provide technical and coaching expertise. They should involve structured syllabus and coaching method designed to improve respective sports skills and techniques across a range of playing standards.

- b. **TALENT DEVELOPMENT AND NURTURING**

- a. They play a role in identifying and developing promising sports athletes. They must be able to offer sports training for a range of playing standards starting from aged 3-18 years old, with a focus on sports excellence.

- c. **EXPOSURE TO COMPETITIVE PLAY**

- a. Academies to nurture and provide opportunities for future stars in the respective sports discipline to compete in various tournaments and leagues; to represent and bring honour to Singapore Recreation Club.
- b. To organise Sports/Boot Camps to provide focused training for the sport discipline
- c. Exposure to new experiences and competitions through travel classes
